As we continue to move forward through the 114th Congress, we are making significant progress. With the recent introduction of H. Res. 590: Establishing a Select Committee on POW and MIA Affairs, a committee that will conduct a full investigation of all unresolved matters relating to any United States personnel unaccounted for from the Vietnam era, the Korean conflict, World War II, Cold War Missions, Persian Gulf War, Operation Iragi Freedom, or Operation Enduring Freedom, including MIAs and POWs missing and captured, we as an organization need to do our part with contacting our representatives in the House and seek their support and cosponsorship. Please contact your Reps. by phone, e-mail, letters and or personal visit. We are seeking 100% compliance!

To date, there are 41 co-sponsors for this bill, including only one Ohio representative.

The original Toxic Exposure Act of 2016 (H.R. 1769 / S-901) went from 19 pages to 331pages when it was merged with a number of other Veteran related legislation.

The new H.R. 5286 was pulled from the floor by the VFW and DAV shortly before it was to be voted on. If this legislation is not voted on be and passed this summer we will have to start over again in January with the new congress.

Ask him to move H.R. 5286 back to the house floor for a vote.

# Medals of Honor History

On July 12, 1862, President Abraham Lincoln approved the legislation authorizing the preparation of 2,000 Medals of Honor (MoH) to "be presented, in the name of the Congress, to such non-commissioned officers and privates as shall most distinguish themselves by their gallantry in action, and other soldier-like qualities."

During the Civil War, U.S. Army Private Jacob Parrott, from Fairfield County, Ohio, was the first recipient of the MoH on March 25, 1863.

According to the Congressional Medal of Honor Society, since then, there have been 3,497 recipients of the MoH. Currently, there are 76 living recipients of the MoH.

Colonel (then Captain) Roger Donlon, U.S. Army, Ret. was the first U.S. servicemember (and the first special forces member) to be awarded the medal for actions during the Vietnam War.



While serving as the commanding officer of the U.S. Army Special Forces Detachment A-726, Captain Donlon and his Special Forces team were attacked by Viet Cong on July 6, 1964.

While two of his fellow comrades were killed, Captain Dolon, who was shot in the stomach and unded three more times during the attack, continued to fight.

After being award the Medal of Honor by President Lyndon Johnson, Captain Donlon commented to the president, "The medal belongs to them, too."

Vietnam Magazine has scheduled an interview with Colonel Donlon that will appear in an upcoming issue.
