

Hello! A Happy Easter to you and everyone at RT1 of Ohio!

I wanted to provide you all with a quick update on Greg's case and our plans for this year's Vietnam Family Meetings in DC.

First, Greg's case analyst has informed us that the excavation proposal has been partially approved. Because it is a single loss site, they want to do what is called an archeological survey first to see if there are any signs of a burial. If they find evidence, then they would do a full excavation. There are some issues with this approach, but we hope to work through this with the help of our analyst. We remain hopeful.

Due to work commitments and the present status of Greg's case, we have decided to forego the meetings this year. We feel that there isn't much we could do there this year as the excavation is most likely, in part, being considered. For the first time in decades, we have full confidence in our analyst.

We wanted to touch base with you about not attending the meetings this year so, in case there is a need elsewhere, you can reallocate those funds.

We are and always will be be extremely thankful for the support that your organization has shown us through our special friendship with Ron and Claudette. I know she would be so excited about this news! I can hear her voice in my mind.

Please send our love to Ron and we hope he is doing well and his health has improved since our surprise visit a few years ago.

Government Affairs, Gus Dante & Mike Wolff

Gus Dante: Mike Wolff and Gus have made it easier on the Government/Veterans Affairs section on the RT National website by providing links so members can get information on anything needed to contact their representatives (Congress and Senate). Gus thanked Mike Maloney, RT National member, for his addition of a link on the Flags, Signs, and Chairs website. Thank you to Nikki and Elaine Muller at our RT National office for all their help in setting this up for the Government Affairs committee. Regarding Senate Bill 693 -"National POW/MIA flag Act", sponsored by Senator Warren Gus was sent the following from Senator Warren's office. So far the Bill has six co-sponsors. Hey Gus, We are working to "hotline" the bill in order to get it passed

without the need for a vote, which would needlessly waste time. Something as bipartisan and uncontroversial as this bill shouldn't need a big timely debate. Right now, we ask that you sit tight while we quietly work with Senators who may be unfamiliar with the bill to explain to them what it seeks to accomplish. No Senator has expressed a problem with the bill, but if one does, we will work with him or her to address any concerns as quickly possible. We will provide you with an update as soon as we have some news! Note that the Senate is in recess until April 29 and not conducting any legislative business (so no bills can get passed), so we won't have any news to share until the Senate returns to session. Hope this explanation helps. Best, Feras Feras Sleiman Counsel Senator Elizabeth Warren Gus sent a letter to Rep. Jerrold Nadler, Chairman of the House Judiciary requesting that RT throughout the country move out of the Subcommittee Constitution on Civil Rights & Civil Liberties. Note: in the last Congress (115th Congress) the Subcommittee was Constitution and Civil Justice. A staffer from Rep. Smith's District office in NJ asked Gus to send a letter to his office. This was done yesterday with the same sent to Nadler's office, but with a few minor changes. Gus read and remarked on the following news item. CONGRESS EXPLORING FLYING POW/MIA FLAG EVERYDAY WASHINGTON (Gray DC) -- The POW/MIA flag may become more prominent in America. Senators are exploring the idea of flying that flag year-round. Anne Mills-Griffiths, the CEO of the National League of POW/MIA Families, said she supports the idea. She said, "There are 1589 Americans that are still unaccounted for or missing from the Vietnam War." More than 40 years after the Vietnam War ended Mills-Griffiths is continuing her mission to bring closure to the families of those service members who were never found. She leads the National League of POW-MIA Families, the group created this flag in 1972. Mills-Griffiths said, "Our objective then was to improve the treatment of POWs." The POW-MIA flag flies over federal


buildings six days a year, such as Memorial Day and Fourth of July. Senator John Thune (R-SD) is supporting a bipartisan bill to fly the flag every single day over buildings like the U.S. Capitol and local post offices. Thune said, "POW-MIA veterans in this country and their families deserve to be recognized that way. All too often they get overlooked." Authors H. Bruce Franklin and Rick Holmes question the original intent of the flag and don't want to see it fly every day over places like the U.S. Capitol.

They say there are better ways to honor service members, like with a symbol of peace, or just simply with the American flag flying by itself. In the Senate, three Republicans and four Democrats are supporting the bill to fly the flag year-round. Copyright 2019 Gray DC. All rights reserved. Gus remarked that Franklin in particular has been against the Vietnam War since the 1960's, and has denied the existence of POW's left behind. He has not changed, and is against Vietnam Veterans. We will continue to push for this Bill, and oppose him.

To date, there are 7 co-sponsors of the Senate bill 5.693 - National POW/MIA Flag Act, And 18 co-sponsors of the House bill H.R.1579 - National POW/MIA Flag Act—still none, so far, from Ohio.

New legislation would recognize nine more diseases caused by Agent Orange By NIKKI WENTLING | STARS AND STRIPESPublished: April 17, 2019

WASHINGTON — A group of lawmakers introduced legislation that would add nine more diseases to a list of conditions presumed to be caused by the chemical herbicide Agent Orange, giving veterans who suffer from them a fast-track to Department of Veterans Affairs disability compensation and health care.

The Keeping Our Promises Act, introduced last week, adds prostate cancer, bladder cancer, hypothyroidism, hypertension, stroke, early-onset peripheral neuropathy, AL amyoloidosis, ischemic heart disease and Parkinson-like syndromes to a list of diseases presumed to be caused by Agent Orange exposure during the Vietnam War.

Researchers with the National Academy of Medicine released findings in November that there was "suggestive" evidence that eight of the diseases could be caused by Agent Orange. For hypertension, researchers found that "sufficient" evidence exists.

"American heroes affected by Agent Orange deserve the peace of mind knowing that the federal government recognizes the existing link between their exposure and illness," said Rep. Brian Fitzpatrick, R-Penn., one of eight lawmakers who banded together to introduce the legislation.

VA experts have begun a "formal, deliberative review" of the National Academy of Medicine's latest report, VA Press Secretary Curt Cashour said Tuesday. The review is expected to be complete in the summer, at which time the agency will make recommendations about presumptive conditions, he said.

During a Senate hearing March 26, Richard Stone, the executive in charge of the Veterans Health Administration, guessed the review would be complete within 90 days.

"We're working our way through that right now," Stone said of the national academy report.

Recommendations would be sent to VA Secretary Robert Wilkie, who would choose when - and whether - to act on them.

The VA previously recommended that some of the conditions be added. After the last National Academy of Medicine report in 2016, the VA took 20 months before it sent recommendations to the White House that bladder cancer, hypertension, hyperthyroidism and Parkinson's-like tremors be added to the list.

The recommendation hasn't made it past the White House's Office of Management and Budget. Last year, VA officials told the House Committee on Veterans' Affairs that the Office of Management and Budget is waiting for results of ongoing mortality and morbidity studies, which could provide more evidence of a connection between the diseases and Agent Orange.

On Tuesday, Cashour said some of those results will be published as early as mid-2019.

But some lawmakers don't want to wait on the executive process.

Fitzpatrick, along with Reps. Annie Kuster, D-N.H., Bruce Westerman, R-Ark., Scott Tipton, R-Colo., Elise Stefanik, R-N.Y., Joe Cunningham, D-S.C., Brendan Boyle, D-Penn., and Mike Thompson, D-Calif., are trying to use a legislative route.

Boyle estimated it would help tens of thousands of Vietnam War veterans.

"This bipartisan legislation makes good on that promise by ensuring all servicemembers exposed to these herbicides and chemicals as a part of their military service get the health care they need," Boyle said in a statement. "Not one more

servicemember should be forced to suffer in this way without the best care our federal government has to offer."

The bill is likely to face an uphill battle in Congress, where veterans and advocates have fought for years to prove toxic exposures and secure VA benefits.

Bowl of Tears

As for me, I call to God, and the Lord saves me. Psalm 55:16

In Boston, Massachusetts, a plaque titled "Crossing the Bowl of Tears" remembers those who braved the Atlantic to escape death during the catastrophic Irish potato famine of the late 1840s. More than a million people died in that disaster, while another million or more abandoned home to cross the ocean, which John Boyle O'Reilly poetically called "a bowl of tears." Driven by hunger and heartache, these travelers sought some measure of hope during desperate times.

In Psalm 55, David shares how he pursued hope. While we're uncertain about the specifics of the threat he faced, the weight of his experience was enough to break him emotionally (vv. 4-5). His instinctive reaction was to pray, "Oh, that I had the wings of a dove! I would fly away and be at rest" (v. 6).

Like David, we may want to flee to safety in the midst of painful circumstances. After considering his plight, however, David chose to run to his God instead of running fromhis heartache, singing, "As for me, I call to God, and the Lord saves me" (v. 16).

When trouble comes, remember that the God of all comfort is able to carry you through your
