First off, I want to let everyone know that we are clearing out the legislation from the 116th Congress and are getting into contact with the 117th Congress to see if past legislation that we are backing will be reintroduced.

As for the end of the 116th Congress, the Johnny Isakson and David P. Roe, MD Veterans Health Care and Benefits Improvement Act of 2020 was passed into law 116-315 on January 5, 2021. It incorporates: • The Deborah Sampson Act of 2020 • The FREE Veterans Act of 2020 • The Financial Refuge for Every Elderly Veteran Act of 2020 • The Navy Seal Bill Mulder Act of 2020.

I want to give you a little background on an amazing woman that the Deborah Sampson Act was named after. Deborah Sampson (1760-1827) Deborah Sampson became a hero of the American Revolution when she disguised herself as a man and joined the Patriot forces. She was the only woman to earn a full military pension for participation in the Revolutionary army. In 1782, as the Revolutionary War raged on, the patriotic Sampson disguised herself as a man named Robert Shurtleff and joined the Fourth Massachusetts Regiment. At West Point, New York, she was assigned to Captain George Webb's Company of Light Infantry. She was given the dangerous task of scouting neutral territory to assess British buildup of men and materiel in Manhattan, which General George Washington contemplated attacking. In June of 1782, Sampson and two sergeants led about 30 infantrymen on an expedition that ended with a confrontation—often one-on-one—with Tories. She led a raid on a Tory home that resulted in the capture of 15 men. At the siege of Yorktown, she dug trenches, helped storm a British redoubt, and endured canon fire. For over two years, Sampson's true sex had escaped detection despite close calls. When she received

a gash in her forehead from a sword and was shot in her left thigh, she extracted the pistol ball herself. She was ultimately discovered—a year and a half into her service—in Philadelphia, when she became ill during an epidemic, was taken to a hospital, and lost consciousness. Receiving an honorable discharge on October 23, 1783, Sampson returned to Massachusetts. On April 7, 1785 she married Benjamin Gannet from Sharon, and they had three children, Earl, Mary, and Patience. The story of her life was written in 1797 by Herman Mann, entitled The Female Review: or, Memoirs of an American Young Lady. She received a military pension from the state of Massachusetts. Although Sampson's life after the army was mostly typical of a farmer's wife, in 1802 she began a year-long lecture tour about her experiences—the first woman in America to do so—sometimes dressing in full military regalia.

Finally, I want to let everyone know about Law # 116-172, The NATIONAL SUICIDE HOTLINE DESIGNATION ACT OF 2020 that was passed on October 17,2020. The number 9-8-8 is the universal number for the national suicide prevention and mental health crisis hotline.



### Serving the Least

The King will reply, "Truly I tell you, whatever you did for one of the least of these brothers and sisters of mine, you did for me." (Matthew 25:40)

His name is Spencer. But everybody calls him "Spence." He was a state track champion in high school; then he went on to attend a prestigious university on a full academic scholarship. He lives now in one of America's largest cities and is highly respected in the field of chemical engineering. But if you were to ask Spence his greatest achievements to date, he wouldn't mention any of those things. He would excitedly tell you about the trips he makes to Nicaragua every few months to check in on the kids and teachers in the tutoring program he helped establish in one of the poorest areas of the country. And he'd tell you how enriched his life has been by serving them.

"The least of these." It's a phrase people use in a variety of ways, yet Jesus used it to describe those who, according to the world's standards, have little or nothing to offer us in return for our service. They are the men and women and children the world often overlooks—if not forgets completely. Yet it's exactly those people Jesus elevates to such a beautiful status by saying, "Whatever you did [for them], you did for me" (Matthew 25:40). You don't have to have a degree from a prestigious university to understand Christ's meaning: serving "the least" is the same as serving Him. All it really takes is a willing heart.

# **Greater Cleveland VA Fisher House**

## What is a Fisher House?

Comprised of two 16-suite homes, the Greater Cleveland VA Fisher House is a "home away from home" for families of military and Veterans receiving care from the Cleveland VA Medical Center and area hospitals. The house provides free, temporary lodging so military and Veteran families who live at least 50 miles or further from the treating facility can be close to their hospitalized loved one during a medical crisis.

The two Fisher Houses provide a comforting, first-class experience while their loved one is receiving care in an unfamiliar environment. This special support relieves the stress of locating a place to stay in an unfamiliar city so the family can focus on supporting their loved one. All the comforts of home are provided to allow families to retreat and rejuvenate after a stressful day at the hospital. While the road to recovery is different for every family, one thing remains the same, the Greater Cleveland Fisher House is there to provide comfort and compassion.

The Fisher House program was established in 1990 by Zachary and Elizabeth Fisher to provide free, temporary lodging to military families, allowing them to be close to their loved one during a medical crisis and focus on what's important – the healing process.

Fisher House guest suites each have a private bedroom and bath. There is a shared common kitchen, laundry area, dining room, living room, library and toys for children. All homes are professionally furnished and decorated and are wheelchair accessible.



More than 1,000 local Cleveland donors including community organizations, Veteran Service Organizations, charitable foundations and individuals combined with national donors over nearly 10 years to raise \$3.4 million. Fisher House Foundation constructed and gifted the houses to the U.S. Department of Veterans Affairs to support the need in Northeast Ohio. With the support and land donation from the City of Cleveland and the Cuyahoga Land Bank, the official Land Transfer Ceremony took place June 30, 2017, the first step in beginning construction. The groundbreaking ceremony took place March 23, 2018, and the Greater Cleveland VA Fisher House opened its doors to its first guest Monday, June 10, 2019.

The Greater Cleveland VA Fisher House is part of VA Northeast Ohio Healthcare System. The healthcare system delivers comprehensive, seamless health care and social services for more than 112,000 Veterans at 18 locations across Northeast Ohio. The Louis Stokes Cleveland VA Medical Center is the healthcare system's hub and operates more than 20 national and regional referral services for Veterans.
