First off, I want to mention that the POW/MIA Flag is back where it belongs atop the White House. In was announced on National Former POW Recognition Day, April 9th. In keeping with the president's commitment to honor the sacrifices of all those who serve, including veterans, their families, caregivers and survivors, the president has restored the POW/MIA flag to its original location on top of the White House residence. The decision followed a bipartisan push for the POW/MIA flag to be restored to its former location by Senators Maggie Hassan (D-N.H.), Elizabeth Warren (D-Mass.) and Tom Cotton (R-Ark), who wrote to The President days after he took office asking that the flag be returned to the top of the White House.

I sent a letter of support to Senator John Boozman to let him know that we support the bill S.657 (A bill to modify the presumption of service connection for veterans who were exposed to herbicide agents while serving in the Armed Forces in Thailand during the Vietnam era, and for other purposes.)

We have been looking into a bill that was introduced by Rep. Kilmer, Derek [D-WA-6] on March 29th . H.R.2281 - To award a Congressional Gold Medal to the United States Army Dust Off crews of the Vietnam War, collectively, in recognition of their extraordinary heroism and life-saving actions in Vietnam. I am preparing a letter of support to send to Representative Kilmer. The bill honors a small group of Americans that have made unique contributions to the American military mission in the Vietnam War. Dust Off was the radio call sign used by helicopter ambulances during the war. These heroic Americans operated regularly with an unwavering dedication to the preservation of human life and sacred American values through their indomitable courage, extraordinary aviation skill, and sound judgement under fire. Helicopters were used for medical evacuation beginning in World War II, but their use expanded during the Vietnam War when about 900,000 U.S., South Vietnamese or allied troops were evacuated, as well as some wounded enemy forces. Able to rescue wounded in almost any weather from almost any terrain, the swishswish-swish or whop-whop-whop noise of an approaching medevac chopper became an iconic sound of the war for soldiers. During 11 years of operation from May 1962 - March 1973 in and over South Vietnam's jungles, the pilots, crews, and medical staff of Dust-off units refined lifesaving techniques and proved the increased odds of survival for combat casualties who could be quickly transported to surgical facilities. This was dangerous duty for the Dust-Off crews, with a 1-in-3 chance of being wounded or killed. These soldiers earned a national reputation for their service in what was considered to be one of the most dangerous jobs in one of the world's deadliest conflicts in the modern era. The Dust-Off crews of the Vietnam War truly embody some of the most talented and heroic service members in American history, these warriors displayed the utmost courage and resilience while under fire by flying to the treacherous front lines to get wounded soldiers out of harm's way. Because of their bravery, hundreds of thousands of lives were saved.

With regard to legislation from the 116th Congress, that is being cleared out and are getting into contact with the 117th Congress to see if past legislation that we are backing will be reintroduced.

REMEMBER: The NATIONAL SUICIDE HOTLINE DESIGNATION ACT OF 2020 was passed on October 17,2020. The number 9-8-8 is the universal number for the national suicide prevention and mental health crisis hotline.

Proper Flag Placement on Bikes (in case anyone is wondering)





Display on Motorcycles

When the U.S. flag is flown alone, it needs to be at the center of the back of the motorcycle, or to its "marching right". The "marching right" is on the right side of the motorcycle to the rider's perspective when facing forward. If the U.S. flag is on your bike with another, it should be to its "marching right". All flags flown with the U.S. flag are the same size and at the same height of the U.S. flag. While the U.S. flag is on your bike with several other flags. The U.S. flag is placed at the center and highest. Other flags should be arranged in alphabetical order and in decreasing importance—nations first, states (in order of admittance) and territories second, military third (in order of establishment) and then others.

I have summoned you by name; you are mine.


<u>Isaiah 43:1</u>
















UPDATE ON GREGORY HARRIS

Dear RT 1 of Ohio,

Greetings from Upstate New York and the Harris Family! First, we send our love to our favorite member of your organization, Ron Svagerko. We miss you, old friend!

Winston contacted us recently asking for an update on Greg's case. In 2016-17 we received a new case analyst, and he was sent from heaven, there is no other way to put it. He listened to us, he worked the case harder than all of our previous analysts combined. He was able to completely disavow the crazy waterwheel and sandbar story and the Department of Defense agreed to begin to look for Greg elsewhere.

The analyst went to Vietnam two or three times and interviewed locals in Greg's loss area. Soon a different story began to develop, and certain pieces of this new story were being corroborated. They now believe that Greg was killed because there was no way to get him out of the area of operation to hold him as a POW so they killed him and left him near a ditch in town. Someone reported having kicked the body of an American into this ditch and remembered exactly where this happened. We now have a spot to excavate.

Sadly, we are now plagued with two problems; 1) COVID has delayed excavations and even if we could get Greg's name on the excavation list, it would be several years before any excavation could take place and 2) because Congress, a few years ago, insisted that DPAA recover at least 200 names a year, the organization has changed their tactics, focusing on recoveries that will give them more bang for their buck. Since Greg is a single loss excavation, he is less likely to be put on the list. In addition, where he is believed to be buried, now has a small local store over part of it and it would cost DPAA quite a bit of money to compensate the town and the store owner to dig up the area.

So, we wait for COVID to come to an end and then we begin the next leg of our journey, getting Greg's name on the excavation list. Yet, we strongly believe that God wouldn't have brought us this far only to have us drop the ball on the 20-yard line. We are regrouping and ready to fight another day.

A warm thank you to you all and we thank you for your support, your prayers and for always remembering our Marine.
